


- 4. The allottee can sell, transfer and /or assign the unit prior to taking over the possession of the same. A written consent of the company for allowing such sale/transfer shall be issued after receiving all current outstanding dues as per payment plan form.
- In case the applicant subsequently wishes to surrender his /her Villa at own accord, it must be intimated in writing and that shall also be subject to deduction of -Services & Establishment Charges" and refund of the Deposited amount shall be made after premises is re-booked.
- The cost of the Villa include uitilty charges, construction charges, electricity supply meters connection charges and gas connection charges.
- 7. The construction of the project is supposed to be completed within specified period from the date of starting of construction, subject to the conditions arising out of Force Majeure, Strikes, Riots, War and other calamities which are beyond the control of the Company.
